Re: Expectations for Your Conduct

Dear Ms. Moser:

Oroville School District strives to maintain a safe learning environment for students, staff, and families. Unfortunately, yesterday you engaged in disturbing conduct during a meeting with Principal Johnson and Athletic Director White. You raised your voice and displayed angry body language. When you were told the meeting would need to be rescheduled because your behavior was escalating, you grabbed a pile of documents from Principal Johnson's desk, raised your voice stating that they were yours and that your children would not sign them. When the Principal reached to take the documents back explaining that the documents were not yours to take, you pulled the forms out of her hand and tore them in half. I reiterate that you grabbed a pile of documents off an administrator's desk, from a larger stack of confidential documents not relating to your own students, you proceeded to sort through these documents to find the ones specific to your own children and tore them up and dropped them back down on the principal's desk. You continued to raise your voice as you exited the meeting room and stormed off out of the main office. A short time later, you reentered the building office, then entered a space generally closed to the public, approached Ms. Johnson at her office threshold and used a loud confrontational voice demanding a call later in the day to reschedule a meeting. A short time later, you phoned the building secretary to schedule your meeting, repeatedly used profanity and said: "Leoni better fucking call when she is done with her fucking meeting so we can finish this;" and threatened: "She better fucking call me today or I will fucking be in the office first thing in the morning."

I note that this is not the first time you have exhibited a lack of emotional control and decorum and exerted aggressive overtones while communicating with school district administrators.

I am sure you will agree that your behavior was highly inappropriate and cannot be tolerated by the District. As a result of your behavior, Oroville School District is issuing an official Criminal Trespass Warning under Chapter 9A.52 RCW.


The District staff has a sincere desire to resolve student disciplinary matters in an appropriate and thoughtful manner. Given your tone and apparent inability to calm yourself during the recent disciplinary meeting, I find that a break from in-person interactions with school personnel is appropriate. I will expect you and the staff to meet and converse through remote means only under this trespass notice. A remote setting means that you may only communicate with district staff via pre-arranged phone and or Zoom conference(s), or via email. This expectation will be in place until further notice and may be revisited prior to end-of-year senior ceremonies. If an unexpected situation arises, you may meet in person only after obtaining my written consent. Such a break is appropriate and will protect our staff from more egregious conduct.

Moving forward, our expectation will be that you never engage in any of the following when interacting with our district staff during the remote setting:

1. Raise your voice in conversations with Oroville School District employees or students
2. Use profanity in meetings or discussions with District employees
3. Make any threatening remarks directed at Oroville School District employees or students or make them feel threatened by your statements or body language in any interactions (on school grounds or other methods of conversation)
4. Engage in personal attacks on staff
5. Raise matters that are not reasonably within the scope of the meeting's purpose

I hope that you may conduct yourself in a more productive and appropriate manner and that we will not need to pursue legal actions to further restrict your access to our staff or school activities.

CRIMINAL TRESPASS WARNING  
WASHINGTON STATE LAW  
CHAPTER 9A.52 RCW**

**CRIMINAL TRESPASS WARNING:** In accordance with the Washington State Criminal Trespass Law, you are hereby ordered not to be on school property. If you come onto school property without the prior permission of the Superintendent, you may be arrested and charged with criminal trespassing.

This criminal trespass warning has been issued as of January 26, 2022 and will be recorded in school records for use by law enforcement.

You are prohibited from being on: Oroville School District property and all school sponsored events. You are prohibited from being on any Oroville School District property except: Via remote setting and or as required for unexpected parent matters if granted written permission from the District.

This criminal trespass warning shall remain in effect until: End-of-year graduation, or until further notice.

**REASON AND BRIEF DESCRIPTION OF EVIDENCE:** The reason and evidence for this action are the following:

**9A.52.070 CRIMINAL TRESPASS IN THE FIRST DEGREE:** A person is guilty of criminal trespass in the first degree if he/she knowingly enters or remains unlawfully in a building. Criminal trespass in the first degree is a gross misdemeanor.

**9A.52.080 CRIMINAL TRESPASS IN THE SECOND DEGREE:** A person is guilty of criminal trespass in the second degree if he/she knowingly enters or remains unlawfully in or upon premises of another under circumstances not constituting criminal trespass in the first degree. Criminal trespass in the second degree is a misdemeanor.
