> The AmazonSmile Participation Agreement states that certain organizations are not eligible to participate in AmazonSmile. We rely on the Southern Poverty Law Center to determine which charities engage in, support, encourage, or promote intolerance, hate, terrorism, violence, discrimination or discriminatory practices based on race, sex, religion, nationality, or sexual orientation thus, making them ineligible for the AmazonSmile program. Center for Self Governance has been excluded from the AmazonSmile program because the Southern Poverty Law Center designated the organization as engaging in one or more of the above practices.

Thank you for contacting us about the removal of the Moms For Liberty Hamilton County TN group.

Due to our privacy policy, I'm unable to share specific details surrounding the report of the group. However, I can say that after our investigation concluded, we found that the group was in violation of our guidelines against Hate/Extremist groups on the platform. One of the resources we use is the Southern Poverty Law Center, which as you have alluded to, has pronounced Moms For Liberty as an extremist group.

Additionally, I cannot speak on any of the content within the group itself as that would also fall under our privacy policy, but I can provide this link which discusses our stance on these types of groups: https://help.nextdoor.com/s/article/Hate-Groups?language=en_US

2. Restricted Users

Certain users may not use our services, regardless of their content. These are: gangs, hate groups, terror organizations, members of the foregoing, and persons who are subject to U.S. sanctions. In certain cases, persons who are subject to sanctions by a non-U.S. government may also be included in this category. In addition, if you are in a country or region that is subject to comprehensive U.S. sanctions, you may not purchase software services or hardware from us. [Read Less](#)

Banned Groups

We define hate groups as organizations that have adopted, based upon its statements, leaders or activities, a hateful ideology. We define a hateful ideology as a set of beliefs that malign a group based upon personal characteristics. For U.S.-based groups, we consider the Southern Poverty Law Center's designations of hate groups to be conclusive. For non-U.S. groups, we may consider governmental or non-governmental designations. The absence of a group from any list of designated hate groups will not be considered evidence that the group is not a hate group.

We define a terror group as a group that seeks to use criminal acts intended or calculated to provoke a state of terror in the general public to achieve political or ideological goals. We deem the U.S. Federal Bureau of Investigation's list of domestic terror groups and the U.S. Department of State's list of foreign terror groups as conclusive, but not exhaustive.

A gang means any organization that uses fear, intimidation, or violence to conduct or further illegal activities or goals. We may consult relevant national and foreign law enforcement lists to determine whether an entity constitutes a gang.

PREVIOUS CONCERN: Note how this official NCIC refers to Terrorist Organization and Terrorist watchlist – like VIMEO deeming FBI “list of Domestic Terrorist group” as “conclusive.”
