

November 21, 2023⁷³ – Air Marshal National Council Director Sonya LaBosco admits TSA using "Quiet Skies" program to follow 'J6' related travelers (U.S. citizens with no FTO connections or criminal charges).

LaBosco: "Our primary mission is "Quiet Skies"...we are following anyone who flew into the capitol...on January 6, 2021...they were put on a specific list...put on this **domestic terrorist list**...

Shimkus: Do those people know they are on this list?

LaBosco: Some of them do...when they go to airport they get quad S on their boarding passes...yet they have not committed a crime...who are no threat to this country"

November 26, 2023 – Controversial figure James O'Keefe goes through Quad-S experience with TSA. NOTE: O'Keefe was raided by FBI in November 2021⁷⁴ allegedly concerning diary of President Biden's daughter.
